## Global Entry Interviews – United States to Offer Interviews in Amsterdam from March 13-17, 2023

## Limited Time Only - Complete your application as soon as possible

U.S. Customs and Border Protection (CBP) would like to announce that CBP Officers will conduct in-person enrollment interviews for CBP's Global Entry program at the Sheraton Amsterdam Airport Hotel and Conference Center from Monday, March 13 – Friday, March 17, 2023.

Global Entry allows expedited clearance for preapproved, low-risk travelers upon arrival in the United States. Participants may enter the United States using automated kiosks located at 62 U.S. airports, and 15 preclearance sites. Global Entry approval also allows U.S. travelers to be eligible to participate in the Transportation Security Administration's (TSA) Pre \( \sqrt{\mathbb{R}} \) program, which expedited screening through TSA checkpoints at participating airports.

On Monday, March 13, 2023, enrollment interviews will be conducted for those with an access code and from March 14-17, 2023, Global Entry enrollment interviews will be made available to the public for U.S. citizens, U.S. lawful permanent residents, Dutch citizens, or citizens of other eligible countries (see country membership in Global Entry here).

For Global Entry applicants who are already conditionally approved, you may be able to complete your enrollment interview without an appointment using Enrollment on Arrival (EoA). When landing in a participating international terminal, follow the signage directing you to CBP officers who can assist you to complete your Global Entry interview during your admissibility inspection. Additional information, including a list of participating airports, can be found on CBP.gov.

## How to Apply

To participate in the interview process at the Sheraton Amsterdam Airport Hotel, you must follow these steps:

- Visit the Trusted Traveler Programs website <a href="https://ttp.cbp.dhs.gov/">https://ttp.cbp.dhs.gov/</a> and review the available programs.
- Step 1: Create a Trusted Traveler Program (TTP) account.

- Here, you must first create an account and then log in to submit an application. When applying, be sure to only select the Global Entry option. A \$100 USD nonrefundable application fee must be paid online at the time you apply.
- Once your application has been submitted, please provide your last name and application number or Pass ID to Dana Johanson (dana.m.johanson@cbp.dhs.gov)
- Once your application has been reviewed, you will receive a message in your account notifying you of the results. If you are "conditionally approved" for Global Entry and are invited to schedule an interview.
- Log into your TTP account and select "Schedule Interview":
  - Enrollment location Amsterdam Airport Sheraton Hotel will display, and you can select the date and time for your interview.

Due to the COVID-19 pandemic, CBP is experiencing a significant backlog of applications. To complete your interview at the Sheraton Amsterdam Airport Hotel and Conference Center, it is recommended you submit your application as soon as possible.

## Renewals

The expiration date for your Trusted Traveler Program membership is displayed on your Dashboard after you log in to the TTP website.

You become eligible to renew your membership 364 days prior to program expiration. If you submit a renewal application before your membership expires, you will be able to continue to use benefits after your membership expiration date. An interview for program membership renewal may not be required.
